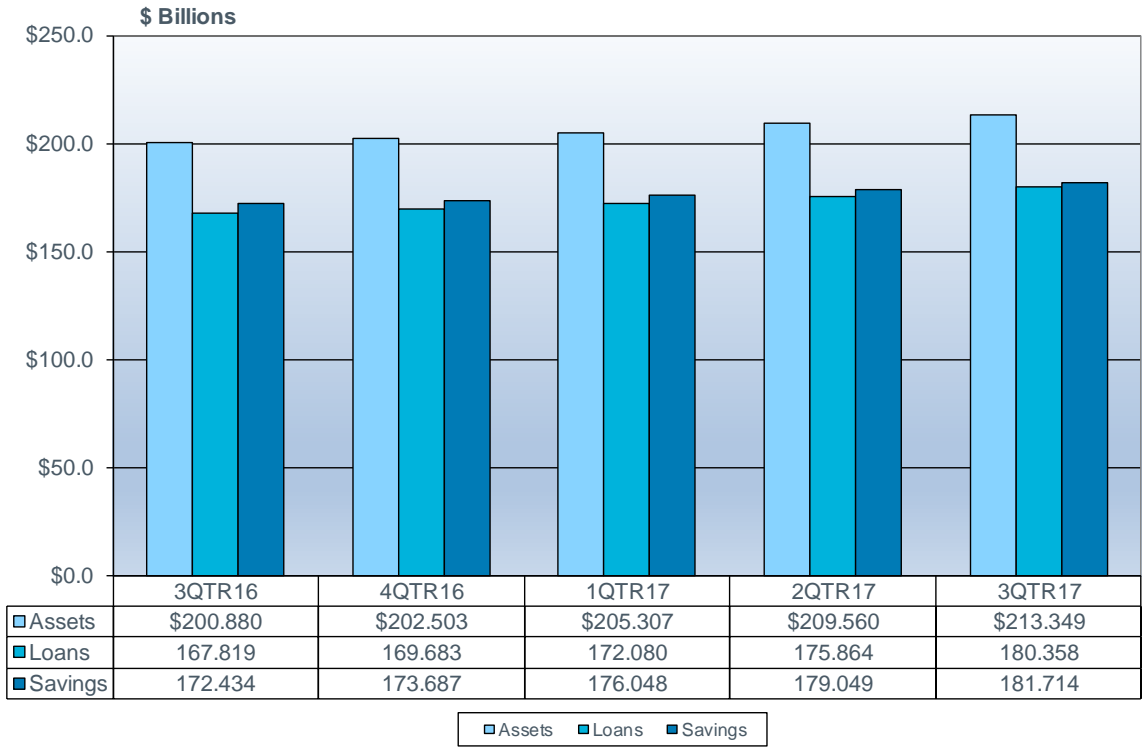
Third Quarter 2017

Solid financial gains continue to be reported by the Canadian credit union sector, with assets, savings/deposits and loans each recording healthy growth in third quarter 2017.

Total assets at Canadian Credit Union Association (CCUA) affiliated credit unions/caisses populaires rose by \$12.5 billion, or 6.2 per cent, over a one-year period to reach \$213.4 billion in the third quarter of 2017.

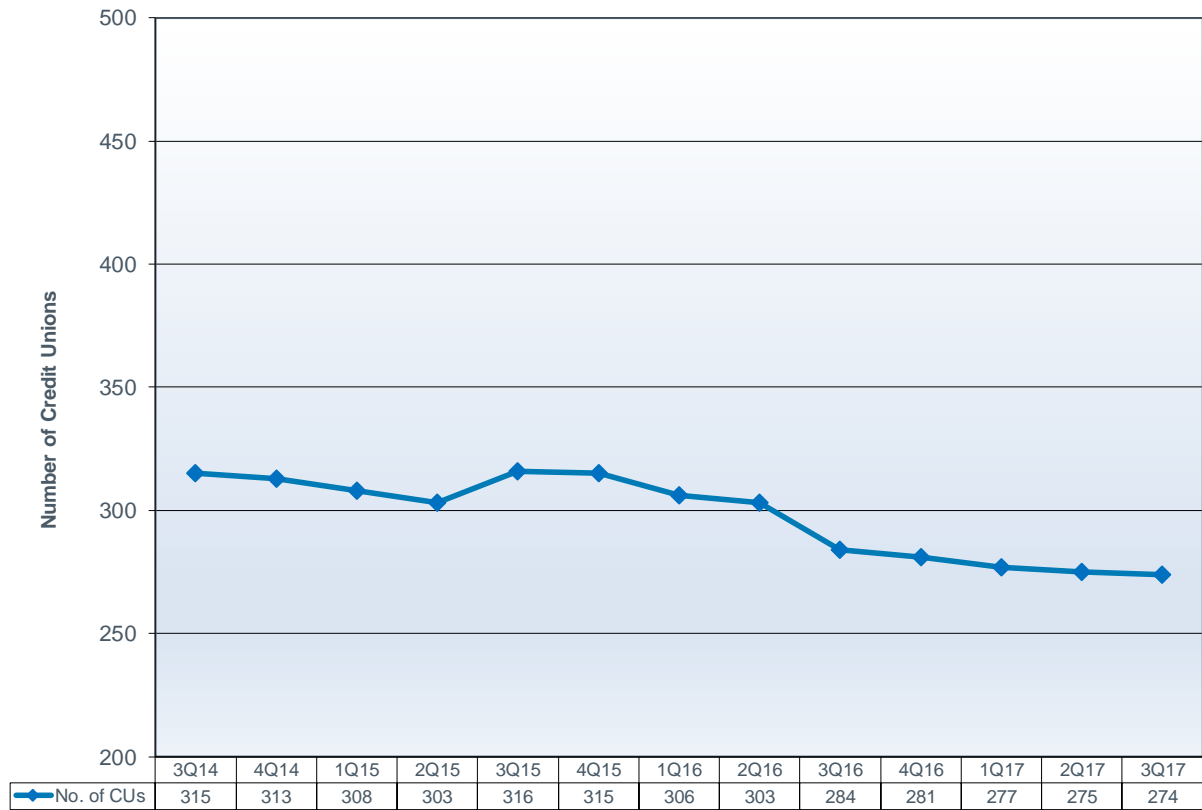
Canadians had \$181.7 billion on deposit with affiliated credit unions and caisses populaires, representing an increase of \$9.3 billion or 5.4 per cent over third quarter 2016.

Lending activity grew by 7.5 per cent. Total loans recorded a \$12.5 billion gain over the previous year, with \$180.4 billion in the portfolio at third quarter 2017.



Affiliated Credit Unions

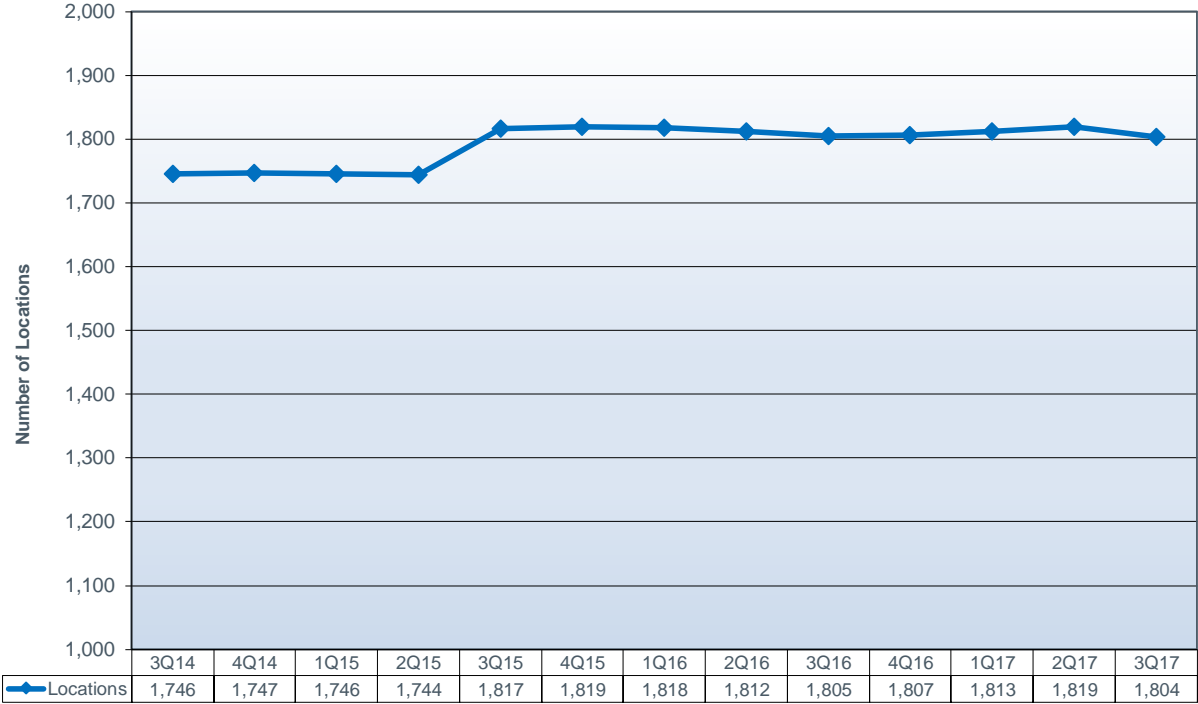
As of third quarter of 2017, there are 274 credit unions and caisses populaires in the CCUA affiliated sector.

At the end of the third quarter of 2017, there are 1,804 locations in the credit union sector.

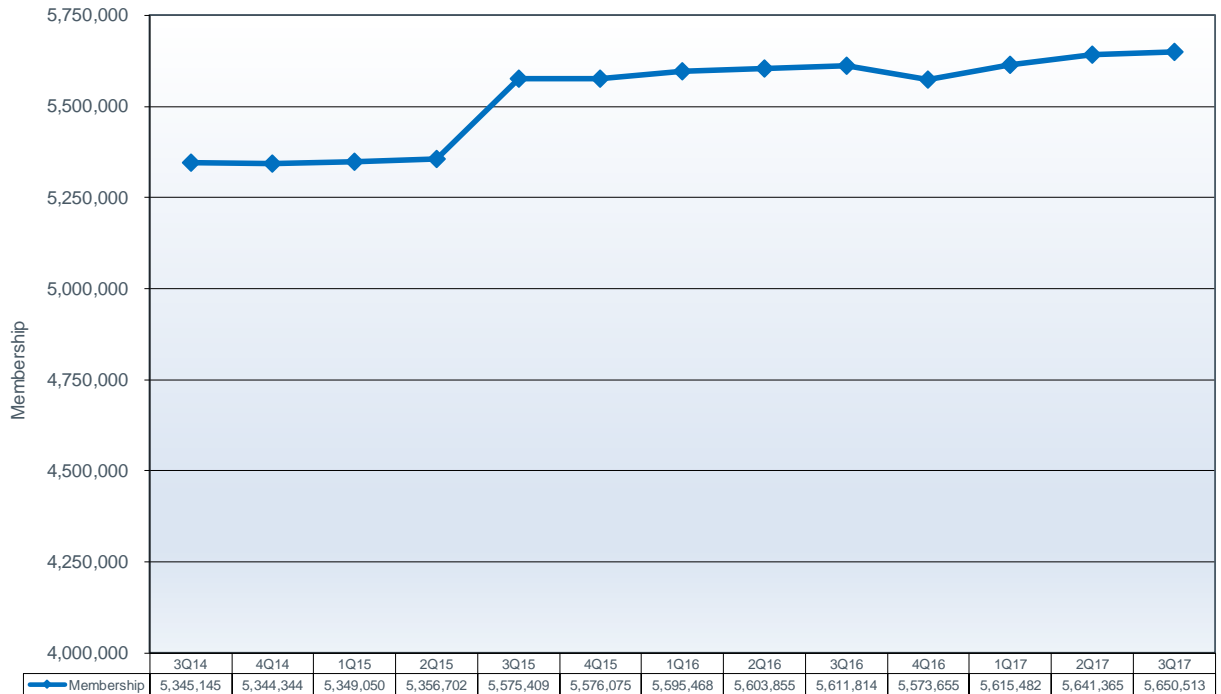
